Sun Child Sponsorship Program is designed to give underprivileged children in Bangladesh the opportunity to become independent and productive citizens by reducing school dropout rates, providing quality education and healthcare, and protecting and promoting child's rights. The SCS Program operates through contributions from American sponsors of \$180 per year.

4b (Code:) (Expenses \$ **25,178** including grants of \$ **23,100**) (Revenue \$)

The purpose of Health for Underprivileged Program is to provide health care and medicine to the residents of slum areas of Dhaka, Bangladesh. The program currently has two active health clinics, which provide care to thousands of patients. DCI social workers and volunteers conduct health surveys in slum areas and identify patients in need of care, with emphasis on maternal health.

The Child Rights Awareness Campaign raises awareness of the needs of underprivileged children and helps find creative solutions. DCI organizes an international Conference on Child Rights & Sight every two years at Yale University, as well as arranges presentations at schools, business institutions, events and gatherings. DCI also arranges child rights benefit concerts and shows with the help of youth volunteers. These shows are interspersed with short presentations on the state of children around the world and what can be done to improve their lives.

A part of the money is given to the child's parent as a stipend. A team of officials make all these arrangements, buys all the necessary materials and distributes them to the beneficiaries.
7. Oversight is in several forms, depending on the country: the NGO itself, federal central government, local project area government and project completion audit by DCI's audit firm, A. Motin and Co., Dhaka, Bangladesh.
8. The NGO is required to submit a yearly financial report and independent audit report to DCI.
9. DCI officials visit the project areas for oversight every year.
