Sun Child Sponsorship Program: provides underprivileged children the opportunity to become independent and productive citizens by reducing school dropout rates, providing quality education and healthcare, and protecting child rights. The program operates in Bangladesh India and Nicaragua.

4b (Code:) (Expenses \$ **170,600** including grants of \$ **83,800**) (Revenue \$)

Orphan Support Program: provides basic necessities such as food and shelter as well as education, healthcare, and skill training to orphaned children. DCI provides support to government-run orphanages in N Bangladesh and also provides sole funding, direction, and oversight for the Sun Child Home orphanage in Dhaka, Bangladesh, which supports 45 orphan girls.

4c (Code:) (Expenses \$ **43,217** including grants of \$ **20,442**) (Revenue \$)

Health for Underprivileged Program: provides healthcare and medicine to residents of slum areas of Dhaka, Bangladesh. The program currently supports one active health clinic, which provides care to thousands of patients. DCI social workers and volunteers conduct health surveys in slum areas and identify patients in need of care, with emphasis on maternal health. The program also provides telemedicine consultation with U.S. doctors.
